Call for Expression of Interest (EOI)

Denjong Charities Trust (DCT). Invites Expression of Interest for Strategic Consultant for the work “Strategic Plan Creation For Taktse International School ”

DCT requires a Strategic Plan for Taktse International School. This plan should include input from a wide range of stakeholders and, in collaboration with the DCT Trustees, clearly articulate the mission/purpose, goals, strategies, and roadmap for the institution over the next 3-5 years.

Eligibility criteria:

The interested parties are required to fulfill the following criteria:

- The firm, individual, or organization should be a registered body. An attested copy of the Registration Certificate should be submitted. Documents like certificate of registration, GST certificate, and PAN card should be submitted.
- The firm, organization, or its members should have adequate experience in strategy-related projects and must have undertaken at least 1 similar project with an unblemished track record of having completed the project successfully.
- The firm, individuals, or organizations are required to produce the original documents against the attested copies, as and when required by the trust.
- The firm/organization should have experience or a resource person in such fields of documentation and training. A list of personnel working may also be submitted.

Time schedule:

The work should be completed within three months of the MOU signing.
